- Signage

- Neighborhood Walk
 - ½ community was monitored-need to finish other portion of community-spreadsheet created with needed repairs/notes

 - Non-compliance with mngt company- take photos-violations of CCR's
 - Consider updating by-laws-allow flags=seasons, sports, etc... but no political-only 3 are allowed=American Flag, Arizona Flag, US military Flag= sports allowed during major sporting events in support of team during the competition/event-(by-laws are 8 years old) when updated? Denise feels our 8 year old By-Laws are old and in need of updating.

 - Denise stated that after 20+ years, Carmine and Alex shouldn't be on the board.
